The Chair thanked all for there attendance and asked all to note that he had received much comment from the area relating to the CCBC decision to extend bin collection to a four weekly cycle. It was noted that the Community Council provides a monthly skip to the village to assist with waste removal and that this year the number of skips provided had been increased which would hopefully assist with the reduction of fly tipping within the Wards of Trefriw and Llanrhychwyn. He asked that on behalf of the Community Council that the County Cllr would pass on the Councils feeling of disapproval over this matter at every opportunity.

7 County Councillor's Report / Adroddiad-y-Cynghorydd Sir

A report from the County Councillor on matters of importance and interest to the community of Trefriw

The County Cllr apologised for submitting his written report late. It was commented upon from the Clerk as to the comment made reference to the Councils lack of interest in providing a Governor to the new school with both Trefriw and Dolgarrog Community Councils being asked by the Governing body to provide a possible candidate. The point made was that no record of the request had been sent to the Clerk and it transpired that only the Cllrs had been sent the email. Cllr Minton made all aware that he had been at Governor at Ysgol Trefriw for many years and was willing to be again to be a school Governor at the new school, the Clerk also commented that he would also be willing to stand if required. It was noted that the proposed opening date for the school is to be September 2019. The County Cllr conveyed to the Council his appointments for the month and based on prior comment made by the Chair voiced concern raised by local residents over the four weekly bin collection cycle. He also stated that he was involved with discussions around rural broadband, had been contacted over "Wellbeing" funding and was involved with proposed road markings outside the Surf Snowdonia site.
