10. Council to discuss Draft Report on Community Council Boundaries

The matter was discussed with varying view points with overall the majority of Cllrs feeling that Trefriw would be better under the jurisdiction of Trefriw Cllrs and not involved with a merger with a another Council. It was felt that more Community Cllrs were needed to show a more democratic balance to the decision making process and that the Welsh Language Policy should be reviewed to ensure that the Council was inclusive to all.

11 Cllr Porter to Update Council on Website Rebuild

Cllr Porter made all aware that the new website was fundamentally complete and that hopefully this weekend 08/07/2018 would be become live. It was noted that the new website could be more interactive and would allow for interaction with other mediums like Facebook should the Council authorise. The Cllr also commented that the ease of use of the new format would lend itself to being updated more readily and posting more information for the Community to easily access.

11.1 Council to discuss and agree funding from Contingency Reserve for Website translation assistance for new Website Resolution: After a short discussion it was agreed by all but proposed and seconded by Cllrs Lees and Sandham to agree funding for any areas of the Website that needed translating into Welsh. No limit was set as no quotes had been obtained, Financial Regs constraints to apply.

- 12.1 Council to discuss Village speed limit, Road Signage within the Village and surrounding areas It was again discussed in relation to the Village speed limit and to road signage with the areas of specific concern being the Tan y Fedw straight / bend to the north of the village which has long been an Agenda item, Gowers Road around the Playground in particular and the Geirionnydd area.

 As detailed in Item 12.1. It was noted that this years Ward Audit had not yet taken place and that last Years was still to be fully completed with attendance by ERF required
- 12.3 Council to discuss and consider action to be taken from the Letter Received from Llanrwst Town Council concerning River bank/ bed erosion in the area of the Llanrwst Bridge
 - After some discussion relating to the "Boundary" it was agreed by all present that in principle Community Council would retrospectively support Llanrwst Town Councils letter to the relevant agencies and would assist as required if consulted.
