	with the trees within Gower Road was estimated to be in excess of £15,000, however, this would likely form the basis of a 5 to 7-year ongoing plan of maintenance with reserves needing to be built up over the next few years in order to meet those costs.	
	On this basis, Cllr Kelly recommended to Council that a working group be formed to manage any programme of works and this would consist of a minimum of two councillors as well as Jay Butters to act as adviser taking in to account his professional qualification. Council moved to vote and it was unanimously agreed by those members present to accept the recommendation. 	Hall as she was aware that this was re-opening but, having made enquiries, she had gleaned that, as the Memorial Hall is run by a charity, they had been able to successfully claim £10,000 grant funding in order to make changes to ensure that the Memorial Hall was Covid secure with such funding not being available to the Community Council.
