#### **Public Footpath Extinguishment and Creation**

### Sections 118 and 26 Highways Act 1980

#### Footpath No.55, off B5106, Trefriw

Conwy County Borough Council is considering the making of the above orders for a public footpath extinguishment and creation for footpath No 55 in the Community of Trefriw.

The footpath being used is not currently recorded as a public right of way and we are seeking to create this under S.26 Highways Act 1980. This is a path that has been maintained and is used by the residents of the community rather than the existing route.

It is our intention to extinguish the short existing path which traverses a steep set of steps and is considered dangerous particularly during certain times of the year. It has not been in use for some time as the alternative route is used. We are therefore seeking to formalise the used path.

The attached plan shows details of the existing unused path and the proposed creation route and also indicates any adjacent or connecting rights of way and/or adopted roads.

I should be obliged to receive your observations and any comments you may wish to make in respect of this proposal and request that you reply before 28<sup>th</sup> November.

If you do not wish to make any observations, I would be grateful if you could acknowledge receipt of this consultation.


