The MOP in attendance, also being a Play Park Trustee, referred members to the possibility of obtaining an independent assessment, given the pre-advice received from a qualified assessor. Following a detailed discussion, members agreed to escalate the Playpark complaint with CCBC to a Stage 2 investigation, as it was considered that all efforts to reach a satisfactory outcome at Stage 1 were now exhausted.
