A person shall be treated as resident if:		
1. His/her ordinary place of residence was in Trefriw or Llanrhychwyn		
2. He/she died while resident in a hospital, nursing home, old people's home or institution of any kind and that his/her last place of private residence was in Trefriw or Llanrhychwyn		
3. He/she had moved away from Trefriw or Llanrhychwyn within the preceding 12 months having been a resident throughout the previous 5 years
